



Deep Geothermal Power On The Way?

GT Energy and the Sandymark Group report that further recent testing and seismic analysis of the potential to harness deep geothermal power at Newcastle has proven to be very encouraging and the group now believes that the resource at this location is of sufficient quality to generate electricity as well as being capable of producing significant quantities of residual heat. They hope to begin construction of the 35 million euro facility in 2011. If all goes according to plan the plant could be producing enough electricity to power the equivalent of 3,500 average sized houses by 2012. The Chamber is delighted with this news as it provides a national lead in the renewable energy sector.

The Chamber strongly believes that renewable energy research and generation as well as supporting industries can play a powerful role in our economic recovery. The Chamber recognises the very supportive role being played by

Minister Conor Lenihan in his role as Minister of State at the Department of Communications, Energy and Natural Resources. Indeed the local political support for this project across most of the political spectrum is very welcome. Given the national significance of the project it is extremely important that whatever needs to be done politically and otherwise is done to ensure that this investment is not derailed.

South Dublin County Sports Partnership

SDCSP is one of a national network of Local Sports Partnerships that was set up in 2001 after funding was received from the Irish Sports Council. It is managed by a Co-ordinator – Thos McDermott – who reports to a management committee made up of representatives from statutory agencies (SDCC, HSE, VEC, CDB), community, primary, secondary & third level education, local area support groups, Souht Dublin Chamber, ethnic minorities and sporting groups (GAA, FAI, IRFU, Athletics, Special Olympics, Federation of Irish Sports). Marc Thornton, DTA Marketing represents South Dublin Chamber on the Management committee.

The principal goal of the SDCSP is to increase participation in sport/physical activity among the community. In particular among certain target groups such as young children, teenage girls and women in general, people with disabilities, disadvantaged (socio-economic), older people and ethnic minorities.

Local Government Savings must be passed back to Business

Chambers Ireland has welcomed the publication of the report of the Local Government Efficiency Review Group. Hilary Haydon, Ratepayers and Local Government Council Chair said, "Restructuring the system of Local Government in Ireland provides a real opportunity to introduce new and more efficient ways of providing local services."



Whilst much of this will require further examination through the White Paper on Local Government, this report provides the first steps to achieving this change.

"We note that if implemented in their entirety, the reforms outlined by the Review Group would result in savings of in the region of €511 million. Given that business has been the funder of 'last resort' for many local authorities, it follows that a significant amount of the cost savings achieved must be passed back to businesses in the form of reduced rates and other charges."
