Submission on the National Skills Strategy



South Dublin Chamber, in association with South Dublin County Council, recognises the need to engage with local businesses and to determine the level and type of business activity, level of exports, employment requirements. In particular their training needs going forward in order that they

may sustain and grow their businesses. To this end in 2014 a major survey was undertaken whereby 4500 individual businesses were directly interviewed and asked to complete a comprehensive business survey. From the survey a detailed database of business activity in the area was established.

In 2015 South Dublin Chamber, again in association with South Dublin County Council and the Local Enterprise Office, conducted a further detailed survey in order to determine more detailed data on the existing and future training needs of businesses. See the Chamber website for more details.



Zero Hour Contracts

The University of Limerick (UL) carried out a study into the prevalence of zero hour contracts (ZHC) and low hour contracts (LHC) in the Irish economy and their impact on employees.

The report finds that zero hour contracts are not extensive in Ireland. There is evidence of so-called If and When contracts. Both types of contract involve non-guaranteed hours of work.

The Department of Jobs, Enterprise and Innovation are now embarking on the development of a Dublin Region Action Plan for Jobs. The Dublin plan is likely to be somewhat different from the already completed Regional Action Plans, given the scale and scope of the agenda.

South Dublin Chamber participated in a Stakeholder Forum designed to shape the Dublin Action Plan with the Minister for Jobs, Enterprise and Innovation, Richard Bruton, T.D. in attendance.



The Public Services and Procurement (Social Value) Bill 2015

This bill requires public bodies to have regard to the economic, social and environmental wellbeing in connection with public services contracts and for related matters.



If a public body enters into a public service contract

or is concluding a framework agreement for the provision of services, the purchase or hire of goods or the carrying out of works, it is obliged before beginning the procurement process to consider the following:

How the deliverance of the contract will meet community benefit requirements.

How the proposed procurement might improve the economic, social and environmental well-being of the relevant area.

How, in conducting the process of procurement, it might act with a view to securing that improvement.

The Living Wage

Since July 2011, the national minimum wage for an experienced adult employee is \in 8.65 per hour. From 1 January 2016 the statutory minimum wage will increase to \in 9.15.



A living wage however is intended to establish an

hourly wage rate that should provide employees with sufficient income to achieve an agreed acceptable minimum standard of living. In that sense it is an income floor; representing a figure which allows employees to afford the essentials of life. The Living Wage proposed is \in 11.50/hour.

Economic Profile Survey of South Dublin County 2014

During April – June 2015, a focussed survey of local business owners and managers was carried out across South Dublin County, following on from the economic profiling survey carried out across 4500 business premises in South Dublin 2014. These businesses then went on to complete a detailed series of Questions as part of the survey.

Employment Outlook

Do you intend to take on new staff in coming months?

40% of business owners were sure that they would be recruiting in coming months, with only 26% saying that it looked unlikely.



If Yes, how many staff do you intend on recruiting?

47% of business owners indicated that they would be taking on 2 staff during the coming year. This is a very positive indicator of growth in the country. Over 30% of businesses indicated that they would be taking on between 3-20 staff.

Almost 30% of businesses who responded are currently exporting with 18% of those not currently exporting expecting that they may export in the future.

Sustainable Business Programme

Tourism



A partnership programme between South Dublin Chamber and South Dublin County Council.

Arising out of the very successful 2014 Economic Profiling Survey it became clear that businesses require substantive training in order to develop and grow. As part of the programme and in continued support of businesses it was decided to undertake a detailed training survey.

Over 200 businesses actively participated in the survey which provided detailed quantitative data on future training requirements in the county. A focus group was established to further investigate and analyse data from the survey. An outcome of the work undertaken in the focus group it became clear that businesses need specifically tailored training courses timed to suit business needs.

As Sustainable Business Executive, Andrea Carroll has met and supported close to 600 businesses over the last five years. She has provided advice to businesses covering a diverse range of current business issues.

A recent initiative in 2015 was the LEO South Dublin Business Support Helpline whereby the Sustainable Business Programme operated a business support helpline, accessible to all businesses in the county and answered business queries within a guaranteed 24 hour time limit, acting as a pathway between businesses and LEO.

Following the merger of South Dublin County Tourism Ltd with South Dublin Chamber, South Dublin Chamber Tourism Industry Group was established. This group will reflect the tourism

industry needs as part of a new tourism strategy for our county. The group is chaired by Brian O'Gáibhín who previously chaired the Tourism Board. The new plan for tourism in our County, "A Tourism Strategy for South Dublin County 2015-2020" predicts the potential for an increase of 2500 new jobs in the sector, the doubling of current spend from

domestic and international tourists to \in 62m by 2025 and the prospect of reshaping perceptions of this part of Dublin. The strategy will serve as the roadmap to unlock the potential of South Dublin County and develop the tourism economy over the next five years.

It is estimated that the tourism sector employs approximately 2,500 in the county and that tourism spend is circa \in 26m from about half a million bed-nights.
