A key function of our Chamber is to represent the views of our members on issues that affect business. We registered as a Lobbying organisation under the new Lobbying Act and to date have made two returns in line with the legislation. This legislation allows us to see who those voices are and who they speak on behalf of.

Our business community is an integral part of the wider community and we need to share our ideas, innovation and concerns with those that provide

the decision making structures of our country. We do this with local Government, South Dublin County Council and with National Government with executive and elected members of both. In 2016 we are focusing on:

- Job Retention / Job Creation.
- Taxation.
- Credit for businesses, many of whom are still experiencing severe cash flow difficulties.
- Illegal trade which undermines many local legitimate businesses.
- Business costs such as rates, energy and transportation, along with national taxation policies that hinder growth and development.
- We promote education and training to ensure we keep a skilled and vibrant workforce in our county.
- We are also lobbying on infrastructure needs such as roads and water.

The decision of Britain to leave the EU is a worrying one. Business needs a high degree of certainty to flourish and this decision, coupled

with elections in many of our key trading partners, we see uncertainty rising. Any of our members who trade with the UK or have logistical input involving the UK will now need to review their forward plans. The Chamber is here to help, either through advice or directing you to the relevant agency that can provide assistance.

Trade is a key component of our local and national economy and to this end we led a Trade Mission to Tampa, Florida in June of this year. Our primary objective of the Trade Mission was to deepen business contacts, engage more closely with the Greater Tampa Chamber of Commerce and to promote South Dublin County as a place to do business and for people to visit, not just as a base in Ireland but as a gateway to the UK and mainland Europe. We are pleased we achieved these objectives and would like to thank all those who participated, particularly our Mayor Sarah Holland who was excellent in offering reasons our county was the place to locate and do business. As a sign of improvement in our economy we continue to see growth in the export documentation service which we provide to exporters in the county on behalf of the Department of Enterprise and Trade.

As business people we tend to be more optimistic than most. A challenge for us all, both private and public sector was to do what needed to be done, better, faster with less resources. This will only be possible through good national leadership, reduced uncertainty and proper fiscal management at the macro and micro level.

### Successful Trade Mission to the US

The Mayor of South Dublin County Council, Sarah Holland lead a delegation from South Dublin County on an official visit to the City of Tampa, Florida, USA from the 30th May to 3rd June.

The Trade Mission, organised by South Dublin Chamber, comprised of representatives from the political, educational and business sectors in South Dublin County including the Mayor of South Dublin County, Sarah Holland, Ms. Sherri Brennan, President and Mr. Peter Byrne CEO of South Dublin Chamber, Mr. Thomas Stone, President of the Institute of Technology Tallaght, Mr. Daniel McLoughlin Chief Executive and Mr. Frank Nevin, Director of Economic, Enterprise and Tourism Development, South Dublin County Council along with business members of the Chamber and Chairs of the Councils SPCs.

When Mayor Holland took office, she outlined her intention to use her role as an ambassador to promote the benefits of South Dublin County as far afield as possible and to promote civic, educational, business and tourism links within Ireland and abroad. One of South Dublin County Council's and South Dublin Chamber's key objectives is to work with enterprise support agencies to increase foreign direct investment into South Dublin County and increase employment opportunities for those living in the county. The aim of the Sister Cities Agreement of Partnership signed by the Mayors of South Dublin County and Tampa City is to improve global cooperation, promote cultural understanding, and stimulate economic development.

This agreement will enable South Dublin County and the City of Tampa to work together, to build a long and lasting friendship that will promote sustainable partnerships that will benefit our respective citizens and develop even further the goodwill that exists between Ireland and the United States of America.

Chamber members now have the opportunity of receiving the full support of the Greater Tampa Chamber of Commerce if they wish to do business in Florida as part of an inter Chamber agreement. This agreement also ensures both Chambers, South Dublin and Tampa promote investment and tourism in the others region.

We look forward to working with the Greater Tampa Chamber of Commerce and are pleased that two Chamber members have already visited the Greater Tampa Chamber of Commerce and engaged with the Chamber in support of their business.

## **Brexit – What Happens Next?**

The vote by the UK to leave the European Union and the change in leadership and key Ministers has created a great deal of uncertainty, in particular, for those who trade or have supply chain logistics involving the UK. We can see the immediate impact of a weakening sterling in the cost to our exporters.

You may be asking yourself what does this mean for me and my business. In short, at this point no one can be totally clear on that answer. No one has left the European Union before (technically Greenland did but they had a very small localised economy) and therefore we cannot look to practice and precedent for guidance.

When Britain invokes Article 50 to leave a timeline will be defined and the future relationship of Britain and the EU will be mapped out. This process will largely throw light on what the consequences for you and your business will be.

In our joint economic profile survey of our County undertaken in 2014, 21% of the business in the county are exporting, of these 75.6% are exporting to the UK so it is a critically important market for our members.

The Chamber will assist you in planning for a changed future environment as the future relationship is determined.

The UK vote to leave is a very significant blow to the EU. It is creating a period of uncertainty and instability in Europe. We need the Irish Government, EU institutions and central banks to do all in their power and remit to minimise financial, economic and political instability. Our challenge going forward is to ensure Irish interests are safeguarded in British EU exit negotiations. Ireland must be centrally involved in these negotiations as we have the strongest trading relationship with the UK in the EU.

We will work to bring certainty to the emerging environment facing employers. This can be achieved through:

- A comprehensive and quickly concluded trade agreement between the EU and the UK whilst recognising the unique relationship between the UK and Ireland.
- The continuation of the long-established Common Travel Area between Britain, Ireland and Northern Ireland.
- A comprehensive and quickly concluded trade agreement between Ireland and the UK, preserving fully the long established free movement of capital, people, goods and services.
- Delivery by the EU on its commitment to increase the EU's competitiveness through reduced administrative burdens and compliance costs on business and repealing unnecessary legislation, as well as pursuing an active and ambitious policy for trade.

We would like to thank the British Irish Chamber of Commerce, Chambers Ireland, Department of An Taoiseach, British Embassy in Dublin and the Irish Embassy in London for the information and support they have given over the past weeks as we seek to understand the issues involved in the debate and understanding the effect it may have on our members.

### Lobbying and Submissions

The Chamber has been very active in the last quarter on your behalf, lobbying and working on initiatives to develop and grow our business economy. A sample of this work is outlined further on in this newsletter, following on from the work outlined in our previous newsletter.

On this site you will find details of all the lobbying activities carried out in Ireland, by individuals and organisations. On your behalf South Dublin Chamber has carried out over 460 individual lobbying acts during 2016, on areas including:

- Education and Training (e.g. Increased Supports for SMEs)
- Economic Development and Industry (e.g. Economic Development Supports in South Dublin)
- Trade (e.g. developing international links including the UK and Australia)
- Tourism (e.g. implementation of the South Dublin Chamber Tourism Strategy)
- Budgetary Matters (e.g. Reduction of Commercial Rates in South Dublin)

Submission re the National Minimum Wage, to the Department of Jobs, Enterprise and Innovation as part of the Low Pay Commission Consultation process

South Dublin Chamber fully supports the work of the Low Pay Commission in determining the appropriate National Minimum Wage, and assisting low paid workers in the economy. However in determining the appropriate National Minimum Wage, the competitiveness of business and the national economy must be considered.

We recommended that the Low Pay Commission give due consideration to the ability of the SME sector to absorb a rise in wage costs without creating a negative impact on competitiveness.

## Submission re Call for Consultation on Education and Skills, to the Department of Education and Skills

#### Promoting Creativity and Entrepreneurial Capacity in Students

South Dublin Chamber advocates for the strengthening of links between local schools, third level institutions and the business community which we consider an innovative way of generating a framework within which students can experiment with ideas and business models. Technological innovation is a prerequisite for an advanced economy, where attracting FDI and growth in the indigenous SME sector is dependent on a knowledge and understanding of STEM (Science, Technology. Engineering and Maths).

#### Meeting the Skill Needs of the Future

South Dublin Chamber supports any structural changes to the Department of Education and Skills that foster innovation and introduce the necessary changes required to deliver a first class education system developed to suit a modern first world economy and society. We also support our Institute of Technology Tallaght, a proactive institute responsive to industry needs.

In recent research we identified that 26% of businesses in South Dublin identify apprenticeship development as a priority. As such we are very supportive of action to develop an Apprenticeship Council for the good of the local economy.

South Dublin County Council is offering financial support to businesses around the county under their Business Support Funds, which has been developed in consultation with participant of the Sustainable Business Programme. These grants include:
